

# Treasurer's Report for the Year 2021

3 May 2022

## Summary

1. With the rollout of vaccines for COVID at the beginning of the year, things started to improve in many ways, including golf. Thanks to good stewardship by the Executive Committee, the NATO Golf Club (NGC) remained financially healthy in 2021. The balance in the Club's bank account at the end of the year was €6,430.75, an increase of €335.71 over the same time last year. A summary of NGC Income and Expenditures, compared to the approved 2021 budget, will be provided separately. In light of our continuing positive financial situation, your Committee recommends that annual membership fees for 2022 remain at €40 for Regular and Associate Members and €25 for Overseas Members.

## **Proposed Budget**

3. The proposed NGC budget for 2022 is attached as **Annex 1**. Approval of this budget will be sought at the Annual General Meeting on 8 May 2022.

### Membership

4. At the end of 2021, we had 31 paid members (16 Regular, 13 Associate, 4 Overseas). This is a drop of 12 from 2020, when the numbers were 20 R, 18 A and 5 O. Considering the circumstances, this drop was expected. But, in the last half of the year, and carrying on into 2022, there has been a slow but steady increase of new members joining NGC.

5. As was done last year by Wolfgang and Katrin Wein, our new Property Manager, Ricardo Guerreiro will submit a separate report.
