

Treasurer's Report for the Year 2018

24 January 2019

Summary

1. The NATO Golf Club (NGC) remained financially healthy in 2018. The balance in the Club bank account at the end of the year was €7,470.68. A summary of NGC Income and Expenditures, compared to the approved 2018 budget, is provided at **Annex 1**. You will see that while we projected a loss of €1,218.45, we actually had a profit of €1.371.59. The outstanding bill of €1,200.00 for logo shirts, ties and scarves from 2017 has still not come in. If received in 2019, they will be paid as a non-forecast expense. In light of our continuing positive financial situation, your Committee recommends that annual membership fees for 2019 remain at €40 for Regular and Associate Members and €25 for Overseas Members.

Club Activities

2. For the historical record, a table of Club activities held in 2018 is provided at **Annex 2.** Despite three cancelations, there was only one fewer event than in 2017.

Proposed Budget

3. The proposed budget for 2019 is attached as **Annex 3**. There is no change in the categories from last year.

Membership

4. At the end of 2018, the number of paid members was 53 (18 Regular, 29 Associate, 6 Overseas). Some members have left and others have joined. Bottom line, we have the same number as at the end of 2017. But we can't rest. There are many who will leave in 2019, including our President. We all need to do our part to attract new members.

Club Property

5. We are very fortunate that Wolfgang and Katrin Wiens have stepped forward to take on the role of Property Manager. They now have all the Club inventory of NGC logo items and will be bringing them to Club events. They also have some great ideas for new stock. They want to hear from the membership, so please share your thoughts with then on what kinds of kit you would like to buy.
