

Treasurer's Report for the Year 2019

31 January 2020

Summary

1. The NATO Golf Club (NGC) remained financially healthy in 2019. The balance in the Club's bank account at the end of the year was €8,187.46. A summary of NGC Income and Expenditures, compared to the approved 2019 budget, is provided at **Annex 1**. Again this year, while we forecast a deficit of approximately €1,000, we made a profit of close to €1,000. This was largely due to the hard work of our Property Managers, who brought in revenues four times greater than in 2018. As a result of the closure of the ARO Kit Shop, we assume the NGC outstanding bill for kit purchased in 2017, has been written off. In light of our continuing positive financial situation, your Committee recommends that annual membership fees for 2020 remain at €40 for Regular and Associate Members and €25 for Overseas Members.

Club Activities

2. For the historical record, a table of Club activities in 2019 is provided at **Annex 2.** Due largely to weather conditions at the beginning of the year, there were two fewer events than in 2018.

Proposed Budget

3. The proposed budget for 2020 is attached as **Annex 3**. This year, there are some changes in the categories. Category #8 Prizes for Turkey and #12 Subsidy for SHAPE Match are deleted, Information Technology Support is added and Category 11 becomes France Trip Subsidy.

Membership

4. At the end of 2019, the number of paid members was 53 (17 Regular, 21 Associate, 15 Overseas). This is the same as we had in 2018, when there were 18 Regular, 29 Associate and 6 Overseas. This favourable position has largely been possible by the very active recruiting efforts of our President. Plus the new ideas and enthusiasm of our Captain.

Club Property

5. As mentioned above our Property Managers, Wolfgang and Katrin Wiens have done an outstanding job renewing our Kit Shop stock and aggressively marketing it. Now all NGC members, old and new, can proudly show their NGC colours. The Wiens have prepared an informal report to providing the state of the NGC Kit Shop. It is distributed separately.
